# Testing & Shelter in Mercer County



- There remains unused testing capacity at Quakerbridge and in Trenton
- Quakerbridge and Trenton sites running smoothly
- Ongoing conversations for how to expand testing
- Test results coming in w/in 1-3 days; this has been varying
- County-wide tracking in HIE; working on local data analysis
- Trenton shelter opened at CEAS Center; additional sites are being worked on to add capacity, but use has been low so far
