CARE MANAGEMENT FOCUSED ON COMPLEX, HIGH-UTILIZING MEDICAID PATIENTS IN TRENTON AND SUPPORTED TB PATIENTS THROUGHOUT MERCER COUNTY. AN EDUCATIONAL COMPONENT WAS ADDED TO THE CARE TEAM PROGRAMMING, AS CHRONIC DISEASE/DIABETES SELF-MANAGEMENT CLASSES WERE MADE AVAILABLE THROUGH PARTNERS THAT SERVE LOW-INCOME, HIGH-NEED CLIENTS. THE COMMUNITY-WIDE CLINICAL CARE COORDINATION TEAM (C4T) BROUGHT KEY PARTNERS TOGETHER TO REVIEW DATA AND ADDRESS VITAL ISSUES AND CONCERNS ACROSS THE CITY OF TRENTON.
