CARE MANAGEMENT FOCUSED ON COMPLEX, HIGH-UTILIZING MEDICAID PATIENTS IN TRENTON AND SUPPORTED TB PATIENTS THROUGHOUT MERCER COUNTY. AN EDUCATIONAL COMPONENT FOR SELF-MANAGEMENT WAS INCLUDED IN CLINICAL SERVICES PROGRAMMING, AS WAS A NAVIGATION AND SUPPORT PROGRAM FOR HIGH-NEED CANCER CLIENTS. A NEW, 5-YEAR PROGRAM IS COORDINATING DIABETES CARE CITY-WIDE. THE COMMUNITY-WIDE CLINICAL CARE COORDINATION TEAM BROUGHT KEY PARTNERS TOGETHER TO REVIEW DATA AND ADDRESS VITAL ISSUES AND CONCERNS ACROSS THE CITY OF TRENTON.
